

ORDER


No. 1770 /CLM/Lic/2016/2017, dated Kolkata, Wednesday, December 13, 2017: Whereas, it has come to notice that while applying of renewal of license under rule 11 of West Bengal Legal Metrology (Enforcement) Rules, 2011 in e-Parimap portal, some licensees are facing problem in submitting GST registration no., which is a requisite document. Now, in exercise to power conferred under section 14(4) of Legal Metrology Act, 2009, it is clarified that save and except as mentioned under section 24 of Central Goods and Services Tax Act, 2017, for those licensees, whose aggregate business turnover as defined under section 2(6) of Central Goods and Services Tax Act, 2017 does not exceed the threshold limit, furnishing GST registration no. is optional and shall type 'NA' against GST No. However, such licensees are required to upload a declaration in e-Parimap portal in plain paper in lieu of GST document stating that such licensee satisfies aforesaid conditions.
