NO.: 3659 – CA/LM/O/2M-8/15

Dated 6<sup>th</sup> November, 2017

In exercise of the power conferred by sub-section (3) of section 14 of the Legal Metrology Act, 2009 (I of 2010) (hereinafter referred to as the Act), and in supersession of Notification no. 2482-CA/LM/O/2M-8/15 dated 20<sup>th</sup> July, 2017 the Governor is pleased hereby to make, with immediate effect the following amendments in the notification no. 1137-CA/LM/O/2M-8/15(PART), dated the 31<sup>st</sup> March, 2017, as subsequently amended (herein after referred to as the said notification):-

*Amendments*

In the said notification, to the Table, add the following Notes:-

"Note 1- For removal of the doubts, it is hereby declared that the local limits for exercising powers of an Inspector of Legal Metrology shall extend to entire territorial jurisdiction of the district concerned and such an Inspector of Legal Metrology shall discharge his duties –

- (a) Para deleted.
- (b) In respect of entire district, as enforcement & inspecting authority under section 15 of the said Act.

Note 2- For removal of doubts, it is hereby further declared that in districts having more than one Inspector of Legal Metrology, the same Inspector of Legal Metrology shall not inspect the premises in the district twice, consecutively, in exercise of his authority under section 15 of Legal Metrology Act, 2009.

Note 3- For removal of doubts, it is hereby also declared that where there is only one inspector of Legal Metrology posted in the entire district such Inspector of Legal Metrology shall exercise his duties as inspecting authority u/s 15 of the Legal Metrology Act, 2009 subject to restriction mentioned in Note 2."



### NOTIFICATION

No.2482-CA/LM/O/2M-8/15, dated the 20<sup>th</sup> July, 2017 – In exercise of the power conferred by sub-section (3) of section 14 of the Legal Metrology Act, 2009 (1 of 2010) (hereinafter referred to said Act), the Governor is pleased hereby to make, with immediate effect, the following amendments in the notification No. 1137-CA/LM/O/2M-8/15(PART), dated the 31<sup>st</sup> March, 2017, as subsequently amended (hereinafter referred to as the said notification):–

#### *Amendments*

In the said notification, to the Table, *add* the following *Notes*:–

“*Note 1.*– For removal of the doubts, it is hereby declared that the local limits for exercising powers of an Inspector of Legal Metrology shall extend to entire territorial jurisdiction of the district concerned and such an Inspector of Legal Metrology shall discharge his duties–

- (a) in respect of the area mentioned in Unit Name, as licensing authority under rules 11 and 12 of the West Bengal Legal Metrology (Enforcement) Rules, 2011; and
- (b) in respect of the entire district, as enforcement or inspecting authority under section 15 of the said Act.

*Note 2.*– For removal of doubts, it is hereby further declared that same Inspector of Legal Metrology posted in any district shall not discharge his duties as enforcement or inspecting authority under section 15 of the said Act in respect of any premises in such district twice consecutively.

*Note 3.*– For removal of doubts, it is hereby also declared that where there is one Inspector of Legal Metrology posted in the entire district, such Inspector of Legal Metrology shall exercise his duties as licensing authority under rules 11 and 12 of the West Bengal Metrology (Enforcement) Rules, 2011 and as enforcing or inspecting authority under section 15 of the said Act subject to the restriction mentioned in Note 2.”
